

SCREENING CRITERIA

GENERAL REQUIREMENTS

- 1. Each adult (18+ years) must complete & sign the rental application and provide a current government issued ID.
- 2. Each applicant must qualify individually OR as a legal couple.
- 3. Incomplete, inaccurate, false, or misleading statements made verbally or on the application will result in denial.

RESIDENCE/RENTAL HISTORY

- 4. We will examine the most recent years of residence history.
- 5. Rental history reflecting any evictions, unpaid rent, damages, or unruly behavior will result in denial or additional security deposit.

INCOME/EMPLOYMENT HISTORY

- 6. We require gross monthly income equal to at least 3x monthly rent per married couple OR each individual applicant
- 7. We will examine the history of all income(s) listed. We will not consider unverifiable income.
- 8. Short term, temporary, or seasonal employment may require an additional security deposit.
- 9. Self-employed individuals must be able to verify their income through tax returns or bank statements.

FINANCIAL/CREDIT HISTORY

- 10. Credit score of 600 required. Lower scores may be considered, but could result in an additional security deposit and/or guarantor
- 11. We reserve the right to deny any applicant/guarantor with a score lower than 600.
- 12. Old bankruptcies will be considered buy may require an additional security deposit if recent.
- 13. No outstanding debt to utility companies.
- 14. Derogatory credit (past due accounts, collections, charge offs, liens, and/or judgments) may result in an additional security deposit or denial.

LEGAL/CRIMINAL HISTORY

- 15. Criminal offenses of a violent nature against either person or property within last 10yrs will result in denial.
- 16. Any pending trial or court cases will result in denial.
- 17. Applicants with a non-violent criminal misdemeanor that occurred more than 2yrs ago or a non-violent criminal felony more than 5yrs ago may be considered if restitution was made in full. Additional security deposit may be required.
- 18. Multiple offences within the last 5 years will be denied.

Complete Applications should include the following 4 items:

- Copy of valid drivers License or ID for each adult over 18 (text or email is fine)
- Copy of last 2 employment pay stubs (text or email is fine)
- Signed and dated Rental Criteria form each adult must sign (text or email is fine)

- Online or Signed and dated paper application – each adult must sign
